Answering Service: Diana B. reporting. There were 25 calls. 4 male, 1 female, 6 referred to website, 13 hangups, and 1 wrong number. Despite the fact that all calls were handled with "Quintessential (most perfect example of quality) Quaesitum (sought objective)", there is an issue with the answering service. This past month's invoice was over \$500. After discussion with answering service, this is due to mismanaged internal procedures & resources. Two alternative answering services were researched by Diana. Motion was made to have Diana investigate if there is a penalty for cancelling contract with current answering service, and if not, drop them. Motion was seconded and passed. Additional motion made to then let Diana set up account with Community Answering Service, which charges flat fee of \$65 per month plus \$1 per outgoing call. Motion was seconded and passed. In light of this situation, Pat C. was told not to pay aforementioned late fee until situation is resolved.

<u>Archives</u>: Nicole M. has organized all archive materials. She is diligently waiting to receive stories from GSRs, including herself, on how their homegroup worked through the pandemic.
